The Public Enterprises Reform and Divestiture (Vesting of Undertaking of Uganda Electricity Board) Instrument, 2001.

(Under sections 25A (1) and 26(4) of the Public Enterprises Reform and Divestiture Statute, 1993,
Statute No. 9 of 1993)

IN EXERCISE of the powers conferred on the Minister responsible for the reform and divestiture of public enterprises by sections 25A (1) and 26 (4) of the Public Enterprises Reform and Divestiture Statute, 1993, this Instrument is made this 29th day of March 2001.

1. Citation.

This Instrument may be cited as the Public Enterprises Reform and Divestiture (Vesting of Undertaking of the Uganda Electricity Board) Instrument, 2001.

2. Vesting of undertaking of Uganda Electricity Board.

(1) The 30th day of March 2001 is appointed to be the date on which the undertaking of the Uganda Electricity Board shall vest in its successor companies, Uganda Electricity Generation Company Limited, Uganda Electricity Transmission Company Limited and Uganda Electricity Distribution Company Limited.

(2) The undertaking of the Uganda Electricity Board shall vest in its successor companies in the following manner—

(a) the assets and liabilities specified in the First Schedule which, before the commencement of this Instrument belonged to the Uganda Electricity Board, are transferred to the Uganda Electricity Generation Company Limited;

(b) the assets and liabilities specified in the Second Schedule which, before the commencement of this Instrument belonged to the Uganda Electricity Board, are transferred to Uganda Electricity Transmission Company Limited;

(c) the assets and liabilities specified in the Third Schedule which, before the commencement of this Instrument belonged to the Uganda Electricity Board, are transferred to Uganda Electricity Distribution Company Limited.

(3) For the avoidance of doubt, except as provided in this Instrument, all assets and liabilities of the Uganda Electricity Board that are not specified in this Instrument shall continue to be vested in the Uganda Electricity Board.
