An Ordinance relating to Estate Duty.

[15TH JUNE, 1917.]

Enacted by the Governor of the Uganda Protectorate.

1. This Ordinance may be cited as "The Estate Short title.
Duty Ordinance, 1917."

2. (1) Where the officer whose duty it is to collect Allowance for
duty in respect
of property in
the United
Kingdom.
estate duty is satisfied that duty is payable in the United Kingdom by reason of a death in respect of any property situate in the United Kingdom and passing on such death, he shall allow a sum equal to the amount of that duty to be deducted from the estate duty payable in respect of that property on the same death.

(2) Nothing in this section shall be held to create a charge for estate duty on any property situate in the United Kingdom while it is so situate or to authorize the Government of the Protectorate to take proceedings in the United Kingdom for recovery of any estate duty.

EXPLANATION:—Any sum payable on probate or administration in the Protectorate under Fee 26 in the Schedule to the Court Fees Rules, 1908 shall be deemed to be included in the term "estate duty" in this section.

THE UGANDA ORDER IN COUNCIL, 1902.

P R O C L A M A T I O N .

I, HENRY RICHARD WALLIS, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor of the Uganda Protectorate, in exercise of the powers conferred upon me by the Uganda Order in Council, 1902, Article 6 (1) with the approval of the Secretary of State for the Colonies do hereby declare as follows:—

The second Schedule to the Proclamation under the Uganda Order in Council, 1902, Article 6 (1) dated the 5th April, 1907, shall be varied from and after the 1st April, 1917, by deleting Mawokota and Butambala from the list of Counties in the District of Mengo in Buganda and adding the said Counties of Mawokota and Butambala to the list of Counties in the District of Entebbe in Buganda.

THE SLEEPING SICKNESS ORDINANCE, 1913.

RULES.

THE SLEEPING SICKNESS (BUKAKATA) RULES, 1917.

1. THESE RULES may be cited as "The Sleeping Sickness (Bukakata) Rules, 1917" and shall be read as one with the Sleeping Sickness Rules, 1913, and the Sleeping Sickness (No. 2) Rules, 1913, hereinafter referred to as the Principal Rules.

2. The Division of the Principal Rules entitled "Additional Rules for the Victoria Nyanza Infected Area, Fishing at Bukakata," is hereby amended by cancelling Section IV. and by deleting the words "the Customs Clerk, Bukakata or" in Section V. c.

3. The following rule is substituted for Section IV. :—

IV. Fishing Licences may be issued by the District Commissioner, Masaka, on payment of a fee of One Rupee. The District Commissioner may, in his discretion (a) refuse to issue a licence to any individual, or (b) cancel any licence previously issued.

CIVIL POST OFFICES IN CONQUERED TERRITORY.

NOTICE.

IT IS HEREBY NOTIFIED for general information that Civil Post Offices will be opened at Bukoba and Mwanza on or about the 11th June, 1917.

2. Transactions at these offices will be restricted until further notice to the exchange of mails and no Telegraph, Money or Postal Order business will be accepted. Parcel Post will be limited at present to delivery only.

3. All classes of mail from Uganda for these ports will be forwarded by the fortnightly "Round Lake" service of steamers leaving Entebbe on alternate Saturdays.

4. The Military system supplies means of telegraphic communication with Mwanza, and additional facilities will be provided as soon as circumstances permit.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having any dealings with any of the persons or firms mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3.

NOTE (2).—Where a person or firm mentioned in the List has more than one address in the same country, all dealings in that country with such person or firm are prohibited, even in cases where one only of the addresses is specifically mentioned.

*NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is however, prepared, on application, to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants, in

making enquiries, would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to His Majesty's Consul-General at New York and to other centres in the United States likely to be interested.
