RULES.

THE PREVENTION OF DISEASE (COTTON AND OTHER TRADES No. 2) RULES, 1917.

1. THESE RULES may be cited as "The Prevention of Disease (Cotton and Other Trades No. 2) Rules, 1917."

2. Sections one and two of Rule 6 of the Prevention of Disease (Cotton and Other Trades) Rules, 1917, are hereby amended by substituting the words "31st December, 1918," for the words "31st December, 1917," therein occurring.

THE STAMP ORDINANCE, 1915.

RULES.

THE STAMP RULES, 1917.

1. THESE RULES may be cited as "The Stamp Rules, 1917," and shall come into force on the 1st December, 1917.

2. Six-cent adhesive stamps of the East Africa and Uganda Protectorates not surcharged with the words "Uganda Revenue" may be used where any instrument is chargeable with a duty of six cents only but may not be used for the payment of any other duty imposed by the Ordinance.

ILLUSTRATION—Two unsurcharged six-cent stamps may not be used on any hawala or bill of exchange on which the duty is 12 cents.

3. Rule 2 of "The Stamp Rules, 1912," is hereby varied accordingly.

IT IS HEREBY NOTIFIED for general information that a Sub-Committee under the Comptroller of Shipping has been appointed for East Africa, consisting of the Chief of Customs as the representative of the East Africa Protectorate and the Agents of the Union Castle Steamship Company, the British India Steam Navigation Company, and the Clan Line, or their nominees.
