THE ROAD ORDINANCE, 1912,  
AND  
THE ROAD (AMENDMENT) ORDINANCE, 1914.

NOTICE.

I HEREBY ORDER as follows:—

1. No person shall use or cause to be used any two-wheeled carriage drawn or propelled by human power upon any public thoroughfare unless it is supplied with and has properly affixed thereto at least two tail ropes.

2. No person shall use or cause to be used any four-wheeled carriage drawn or propelled by human power upon any public thoroughfare unless it is supplied with and has properly affixed thereto a scotch and at least two tail ropes.

3. No person shall use or cause to be used any carriage drawn or propelled by human power upon any public thoroughfare unless the following conditions are observed:—

(a) The load thereon shall not be greater than sixteen hundredweights;

(b) The height from the surface of the public thoroughfare to the top of the load shall not exceed eight feet.

(c) No part of the carriage or load shall project beyond the naves of the wheels on either side.

4. Every licence issued for a carriage drawn or propelled by human power may be endorsed in accordance with the provisions of this Notice.

5. The Notice under the above-mentioned Ordinances dated the 5th May, 1916, is hereby cancelled but without prejudice to any penalty incurred or to the prosecution of any offence committed before the date hereof.
