THE COURTS ORDINANCE, 1911.

PROCLAMATION.

KABALE NATIVE COURTS.

1. PARAGRAPH 1 (a) of the Proclamation dated the 29th October, 1915, establishing Native Courts in the District of Kabale is hereby amended by deleting therefrom the words "Each consisting of the persons from time to time appointed by the Governor in that behalf" and substituting therefor the words "Each consisting of the persons from time to time appointed in that behalf by the Governor or by the District Magistrate, if authorized by the Governor to make such appointments."

2. Paragraph 1 (a) (i) of the said Proclamation is hereby cancelled and the following substituted therefor, *viz.* :—

"1 (a) (i) Civil cases in which the subject matter in dispute consists of cattle and does not exceed 50 head of cattle and other civil cases in which the amount or subject matter in dispute does not exceed in value Rs. 200/-."

3. Paragraph 1 (a) (ii) of the said Proclamation is hereby amended by inserting therein the words and figures "or whipping not exceeding 24 lashes" immediately after the words and figures "fine not exceeding Rs. 150/-" therein occurring.

4. Paragraph 1 (a) of the said Proclamation is hereby further amended by inserting therein immediately after sub-paragraph (ii) thereof the following, *viz.* :—

"(iii) Appeals from the Sub-Divisional Courts in their respective Counties; provided that the County Court of Rukiga shall have jurisdiction to hear and decide appeals from the Sub-Divisional Courts of Kinkizi and Kayonsa in addition to those from the Sub-Divisional Courts in the County of Rukiga."

5. Paragraph 1 (b) of the said Proclamation is hereby amended by deleting therefrom the words "Each consisting of the person from time to time appointed by the Governor as president, sitting with any two or more of the sub-chiefs of the sub-division" and substituting therefor the words "Each consisting of the persons from time to time appointed in that behalf by the Governor or by the District Magistrate, if authorized by the Governor to make such appointments, and presided over by the person appointed by the Governor for that purpose or in his absence by such other member of the Court as may be directed by the District Magistrate."

6. Paragraph 1 (b) (i) of the said Proclamation is hereby cancelled and the following substituted therefor, *viz.* :—

"1 (b) (i) Civil cases in which the subject matter in dispute consists of cattle and does not exceed 20 head of cattle and other civil cases in which the amount or subject matter in dispute does not exceed in value Rs. 75/-."

7. Paragraph 1 (b) (ii) of the said Proclamation is hereby amended by inserting therein the words and figures "or whipping not exceeding 10 lashes" immediately after the words and figures "fine not exceeding Rs. 30/-" therein occurring.

THE UGANDA CUSTOMS CONSOLIDATION
 ORDINANCE, 1904.

NOTICE.

1. THE SCHEDULE to the Notice under the above-mentioned Ordinance dated the 30th July, 1917, as amended by the Notice of 22nd September, 1917, is hereby further amended by deleting therefrom the heading:—

“a hides of cattle, buffaloes, and horses.”

and by inserting therein the heading:—

“a hides of cattle, buffaloes, and horses weighing less than eight pounds.”

2. I hereby prohibit the export of hides of cattle, buffaloes, and horses weighing eight pounds or more to all destinations other than ports in the United Kingdom.

RULES OF COURT.

Made by the High Court with the approval of the Governor, under Article 22 of the Uganda Order-in-Council, 1902.

No. 2 of 1917.

KABALE NATIVE COURTS.

1. THESE RULES may be cited as "The Kabale Native Courts (Amendment) Rules, 1917," and shall be read as one with the Kabale Native Courts Rules, 1915, (hereinafter referred to as the principal Rules).

2. Rule 4 of the principal Rules is hereby amended by inserting therein the words "and every sentence of whipping" immediately after the word "imprisonment" therein occurring.

3. Rule 5 of the principal Rules is hereby cancelled and the following substituted therefor, *viz.* :—

"5. When any sentence of imprisonment is passed by a Native Court, the District Magistrate or an Additional District Magistrate, Kabale, shall, subject to any judgment or order made on appeal or revision, sign the warrant of commitment in accordance with such sentence, which shall be carried out in a prison declared under the Uganda Prisons Ordinance, 1909."

4. The fee leviable on appeal from a Sub-Divisional Court to a County Court shall be 2 Rupees, and fee 3 in the Schedule to the principal Rules is hereby amended accordingly.

5. It is impossible to estimate the effect of this force upon the plans of the enemy in the adjoining territory of German East Africa. The Reserve was virtually a body of trained men accustomed to the country and in whom the natives of the Protectorate had confidence, who could be called upon at any time, and were ready, to support the very thin line of Police and native levies by which the frontier was held, should any advance be made by the enemy. In fact, with the Civil Police and such native levies as could be hastily mobilized, it formed the only defence as, during the earlier months of the war, all the King's African Rifles were withdrawn for service in East Africa, and I have good reasons to believe from reports subsequently received that the mobilization of the Uganda Volunteer Reserve did much to prevent invasion of the Protectorate during the period which elapsed before adequate defence arrangements could be made by the Military authorities.

6. As a Unit, the Uganda Volunteer Reserve took no active part in local operations but, at a later period, when the forces in Uganda became merged in the military command in East Africa, many of the members of the Reserve, officials and non-officials, were drafted to local Units operating on the frontier, and that a greater number did not take part in active hostilities was due to the fact that a large proportion of the members consisted of Government officials who could not be spared from their official duties. The Government service was, however, reduced to a minimum in order to allow as many officials as possible to take part in military operations, and business firms only retained a skeleton of their former staffs.

7. The period for which the members of the Uganda Volunteer Reserve were called out for service in Uganda was terminated on the 24th August, 1916, as it was then felt they could, with safety, be disbanded.

8. With regard to paragraph 2 (b) of the despatch under reply, all officers of the Uganda Volunteer Reserve rendered valuable services in connexion with the training of the force, but the following individuals deserve special mention :—

MR. HENRY RICHARD WALLIS, C.M.G., CHIEF SECRETARY TO THE GOVERNMENT.

Mr. Wallis was acting as Governor and Commander-in-Chief when war was declared, and it was largely owing to his initiative and the prompt and effectual measures he took in co-ordinating the forces available for the defence of the Protectorate that an enemy invasion was averted.

CAPTAIN CHARLES RIDDICK, COMMISSIONER OF POLICE.

Captain (temporary local rank of Lieut.-Colonel) Riddick was appointed Commandant of the Uganda Volunteer Reserve on 9th November, 1914, shortly after his return from leave, and continued to take an active interest in the administration of the Reserve until their period of service was terminated.

CAPTAIN E. H. T. LAWRENCE, ASSISTANT COMMISSIONER OF POLICE.

Captain (temporary local rank of Major) Lawrence, then Acting Commissioner of Police, was appointed Commandant of the Uganda Volunteer Reserve on the outbreak of hostilities, and it is due to the energetic measures which he took when the Reserve was called out that the force was organized and brought to the standard of efficiency to which it attained. He continued to act as Adjutant until he assumed Command of the Uganda Police Service Battalion, operating on the Southern frontier of the Protectorate.

CAPTAIN F. A. FLINT, SUPERINTENDENT OF POLICE.

Captain (temporary local rank of Major) Flint was in Command of the Entebbe Company of the Uganda Volunteer Reserve and showed indefatigable zeal and energy in the discharge of his duties. He was also in charge of the Garrison troops at Entebbe and the native patrols on Lake Victoria.

MR. EDWARD BLACKWELL JARVIS, ASSISTANT CHIEF SECRETARY.

Mr. Jarvis is a Private in the Uganda Volunteer Reserve. When the Force was re-organized, on the outbreak of hostilities, he was acting as Chief Secretary to the Government and, in that capacity, had to take an active part in the consultations and arrangements which were necessary to give effect to the altered conditions.

SIR,

I have the honour to inform you that Sir F. Jackson's despatches No. 336 of the 5th September, 1916, submitting the names of individuals whose special services he desired to bring to notice, and No. 362 of the 30th December, 1916, calling special attention to the services of the Uganda Volunteer Reserve in connection with local defence measures taken as a consequence of the outbreak of war, were duly laid before the Army Council.

2. The Council as a result of their consideration of such despatches from Governors of various Colonies decided to make special public notification of the names of those deemed to be deserving of recognition, although their services may not have been of such a nature judged by the standard applied in the case of actual operations in the field as to make it possible to accord the recognition known as a "mention in despatches" or any higher reward.

3. In a War Office notice published through the Press Bureau on the 7th August, (copy enclosed) you will find the names of three officers of the Uganda Volunteer Reserve. I suggest that this list should be published in the *Uganda Official Gazette* accompanied by a concise notice giving particulars of the service rendered in each case, together with Sir F. Jackson's despatch No. 362 and this reply, in which I gladly take the opportunity of commending the valuable services rendered by the Uganda Volunteer Reserve.

4. The Army Council have not thought it within their province to make any notification of the civilians mentioned in Sir F. Jackson's earlier despatch, but I am treating that despatch as one of special recommendation for any reward that may be thought possible; and in these cases as well in those of the names noticed by the War Office you will be good enough to cause a note to be made on the officers' records of service.
