# The Uganda Wildlife (Declaration of Wildlife Conservation Area) (Kibale National Park) Instrument, 2003.

(Under sections 18, 19 and 94 of the Uganda Wildlife Statute, 1996, Statute No. 14 of 1996).

IN EXERCISE of the powers conferred upon the Minister responsible for wildlife by sections 18, 19 and 94 of the Uganda Wildlife Statute, 1996; and after consultation with the local government councils of Kabarole, Kamwenge, and Kasese Districts; and with the approval of Parliament signified by its resolution passed on 27th May 2002, this Instrument is made this 3rd day of April, 2003.

## 1. Citation

This Instrument may be cited as the Uganda Wildlife (Declaration of Wildlife Conservation Area) (Kibale National Park ) Instrument, 2003.

#### 2. Declaration of Kibale National Park as wildlife conservation area

The area of land specified in the Schedule to this Instrument is declared a wildlife conservation area to be known as Kibale National Park.

### 3. Area to be a national park and a wildlife protected area

The area declared under paragraph 2 shall be a national park and a wildlife protected area for the purposes of section 19 of the Uganda Wildlife Statute, 1996.

### 4. Revocation of S.I. No. 221 of 1964.

The Game Reserves Declaration (No. 6) is revoked.

## 5. Amendment of S.I. No. 227-1 and S.I. No. 76 of 1993

The National Parks (Declaration) Order and the National Parks (Declaration) Order, 1993 are amended by revoking any reference to Kibale National Park

#### SCHEDULE.

#### **Boundaries of Kibale National Park.**

The area formerly known as Kibale Central Forest Reserve as indicated on Forest Department Boundary Plans 1089, 1639 in the Forest Reserve (Declaration) Order, 1968, together with Queen Elizabeth

National Park-Kibale Forest Corridor Game Reserve as declared by the Game Reserve Declaration (No. 6) Notice 1964 [as amended by the Game Reserve Declaration (Amendment) Notice 1965].

Boundary is more particularly shown on Plan UG/WILDLIFE/KBNP/01 is deposited at the Survey Records Office in the Department Responsible for Surveys and Mapping.
